Bed 'n' Biscuits Pet Agreement

This is an Agreement between Bed 'n' Biscuits and the pet owner (hereinafter called "Owner") whose signature appears below.

1. Owner agrees to pay the rate for pet care provided in effect on the date pet is checked into Bed 'n' Biscuits.
2. Owner agrees to pay all costs and charges for special services requested and all veterinary costs for pet during the period said pet is in the care of Bed 'n' Biscuits.
3. Owner agrees that pet shall not leave the facility until all charges due are paid by Owner or proper payment arrangements are agreed upon by both parties.
4. Owner agrees that all checks are deposited the day they are received. A service charge of \$25 will be assessed when checks fail to clear the bank on which drawn. The service charge will be increased to \$40 if the check is not redeemed within one week.
5. By signing this Agreement and leaving pet with Bed 'n' Biscuits, Owner certifies to the accuracy of all information given about said pet. Bed 'n' Biscuits reserves the right to deny admittance to Owner's pet for any reason at any time.
6. Bed 'n' Biscuits shall exercise reasonable care for the pet delivered by Owner to Bed 'n' Biscuits. If interactive daycare is provided, Owner recognizes and accepts potential risks involved in such activity. It is expressly agreed by Owner and Bed 'n' Biscuits that Bed 'n' Biscuits liability shall in no event exceed the lesser of the current chattel value of a pet of the same species per animal admitted. The Owner further agrees to be solely responsible for any and all acts of behavior of said pet while it is in the care of Bed 'n' Biscuits, to include payment of costs for injury to staff or other animals or damage to facilities caused by the pet.
7. There is always the possibility a grooming accident could occur. Grooming equipment is sharp, and even though we use extreme caution and care in all situations, possible problems could occur including cuts, nicks, scratches, quacking of nails, etc.



8. Owner specifically represents to Bed 'n' Biscuits that, to the Owner's knowledge, pet has not been exposed to any contagious diseases within a 30 day period prior to check-in. During the period of this Agreement, Owner also agrees to notify Bed 'n' Biscuits of any known exposure of pet to a communicable disease and keep pet from attending Bed 'n' Biscuits until pet is symptom-free for a minimum of 10 days or has veterinary clearance. Owner further agrees to maintain currency of vaccinations as required by Bed 'n' Biscuits.

9. Owner specifically represents that he or she is the sole owner of pet, free and clear of all liens and encumbrances.

10. All charges incurred by Owner shall be payable upon pick-up of pet or when billed by Bed 'n' Biscuits. Bed 'n' Biscuits shall have and is hereby granted, a lien on pet for any and all unpaid charges resulting from services provided by Bed 'n' Biscuits. The Owner agrees that in the event the charges are not paid when due in accordance with this contract, Bed 'n' Biscuits may exercise its lien rights upon 10 days written notice given by Bed 'n' Biscuits by certified mail to address shown on contract.

11. If pet becomes ill or is injured, or if the state of the animal's health otherwise requires professional attention Bed 'n' Biscuits, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the animal, and the expenses thereof shall be paid by Owner.

12. It is further understood this clause applies to any and all pets groomed.

13. Any controversy or claim arising out of or relating to this Agreement, or the breach thereof, or as the result of any claim of controversy involving the alleged negligence by any party to this Agreement, shall be settled in accordance with the rules of the American Arbitration Association, and judgement upon the award rendered by an arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of the award, determine an award to the prevailing party of the costs as such arbitration and reasonable attorney's fees of the prevailing party.

Daycare, Boarding, & Grooming

Policies

The purpose of Bed 'n' Biscuits is to provide a safe, fun, and stimulating social environment for your pet during your weekday business hours, weekends, and vacations. To ensure the safety and health of your pet and our other guests, we require all guests to comply with the following rules and regulations:

Spaying & Neutering: We do not require pet(s) be spayed or neutered. We are not liable for any incidences that may occur. Although we monitor our dogs closely, accidents can happen. Owners that bring in their unaltered dogs are expected to understand the risk of male and female interaction. All cats must be Spayed/Neutered before coming to our facility.

Shots: All dogs must have up-to-date vaccinations. Owners must submit written proof of current DHLPP (Parvo, Distemper, Leptospirosis) and Bordetella vaccinations for dogs, and Rabies vaccinations are required for all dogs and puppies over 4 months of age.

Health: All pets must be in good health. Owners shall certify their pet(s) are in good health and have not been ill with a communicable condition in the last 10 days. Upon admission, all pets must be free from any condition which could potentially jeopardize other guests. Pets that have been ill with a communicable condition within the last 10 days will require veterinarian certification of health to be admitted or re-admitted.

It is the owner's responsibility to notify staff of any pre-existing injury's, needed medications, or any other health concerns related to their animal.

Behavior: We do not require dogs to take temperament tests or pass behavior evaluations. We do not have any breed restrictions and accept reactive dogs. It is the owner's responsibility to inform us of any aggressive behaviors. Any and all dogs that are not well socialized will be kept in a separate area away from other dogs. We reserve the right to deny acceptance to any dog at any time.

Enrollment Application & Pet Care Agreement: All pet owners must have an up-to-date and approved Application and signed Agreement on file in our office.

Fees: Fees are based on a daily rate or Saving Package Plan. Saving Package Plans offer substantial discounts from the daily rate and range from 7 to 21 days. All Packages expire 1 year after date of purchase.

Monday through Saturday from 7:00 a.m. to 7:00 p.m.

Sunday from 7:30 p.m. to 6:00 p.m.

Drop-Off & Pick-Up:

- Monday - Saturday Drop off/ Pick-up Hours 7:30 a.m. to 6:15 p.m.
- Sunday - Drop Off/ Pick-up Hours 8:00 a.m. to 5:15 p.m.
